M/WBE Summary

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 188 firms on January 28, 2009. The RFQ was obtained by 26 firms, and three firms submitted qualification statements. None of the firms were certified M/WBE firms. Of the three firms evaluated, three firms were short-listed and interviewed. Interviewing of the short-listed firms resulted in the following recommendation:

Participation sub-goals stated in the solicitation were **1.90%** African American; **9.00%** Hispanic; **4.90%** Native/Asian; **15.80%** WBE. The recommended and alternate firm both provided an MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.
