

M/WBE Summary

Participation subgoals stated in the solicitation were **1.9%** African American; **9.0%** Hispanic; **4.9%** Native/Asian and **15.8%** WBE. The recommended firms provided MBE/WBE Compliance Plans that met the goals of the solicitation and were approved by the Department of Small and Minority Business Resources.

Notification of issuance of a Request for Qualifications (RFQ) for the subject services was sent to 192 firms on Friday, October 23, 2009. The RFQ was obtained by 63 firms, and 19 firms submitted qualification statements. None of the firms were certified MBE/WBE firms.
