

M/WBE Summary

Bid documents were distributed to 11 general contractors. Bids were opened on March 11, 2010. Bids include a \$1,500 allowance for tree fertilization and a \$10,000 allowance for source water for testing and flushing. TRCU, LTD., Houston, TX, submitted the lowest bid of the 7 bids received:
