Bid documents were distributed to 22 general contractors. Bids were opened on March 4, 2010. Muniz Concrete & Contracting Inc. submitted the lowest of 5 bids received:

The contractor's choice of work methodology provides for subcontracting opportunities in eight areas: Demolition, Construction of water systems, Fencing, Erosion Controls, Construction Photography, Crane Rental, Lead/Asbestos Abatement, and Electrical. Participation subgoals stated in the solicitation were **2.09%** African American; **4.74%** Hispanic; **0.41%** Native/Asian; and **1.82%** WBE.
