# AN ORDINANCE ORDERING A SPECIAL ELECTION TO BE HELD IN THE CITY OF AUSTIN ON NOVEMBER 2, 2010, FOR THE PURPOSE OF AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION FUNDS; AND DECLARING AN EMERGENCY. 

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. A special municipal election shall be held in the City of Austin on November 2,2010 , for the voters to consider the issuance of general obligation bonds.

PART 2. The qualified voters shall vote for or against the bond proposition as set forth in Part 1 of Ordinance No. 20100805-005B, attached as Exhibit A and incorporated as a part of this ordinance.

PART 3. The proposition shall appear on the official ballot in substantially the form set forth in Part 2 of Ordinance No. 20100805-005B.

PART 4. The election shall be conducted between the hours of 7:00 a.m. and 7:00 p.m. The precincts and locations of the election day polling places; the dates, hours, and locations of the early voting places; and the names of the officers appointed to conduct the elections are provided in Exhibits B-F attached and incorporated as a part of this ordinance.

PART 5. A direct electronic recording voting system shall be used for early voting and for voting conducted on election day. The central counting station is established at the Travis County Elections Division, 5501 Airport Boulevard, Austin, Texas.

PART 6. Notice of this election shall be given by posting and publishing a copy of this ordinance in both Spanish and English. The notice shall be posted at three public places and the City Hall notice kiosk not later than the $21^{\text {st }}$ day before election day; the notice posted at City Hall shall be accompanied by a cover page, at the top of which shall appear the words "A SPECIAL MUNICIPAL ELECTION, NOVEMBER 2, 2010". The ordinance shall be published twice in a newspaper of general circulation in the City of Austin not earlier than the $30^{\text {th }}$ day and not later than the $10^{\text {th }}$ day before election day; publication shall be on the same day in each of two successive weeks, and first publication must be not less than 14 days before the date of the election.

PART 7. The November 2, 2010, special municipal election may be held jointly with the various political subdivisions that share territory with the City of Austin and that are
holding elections on that day. The terms of the joint election agreement(s) are stated in Exhibit G and hereby adopted.

PART 8. The Council finds that the need to immediately begin required preparations for this election constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.

## AN ORDINANCE ESTABLISHING BOND PROPOSITION LANGUAGE FOR THE NOVEMBER 2, 2010, SPECIAL BOND ELECTION; AND DECLARING AN EMERGENCY.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council establishes that the following bond proposition language be presented to the voters at a special bond election on November 2, 2010:


#### Abstract

SHALL THE CITY COUNCIL OF THE CITY OF AUSTIN, TEXAS, BE AUTHORIZED TO ISSUE AND SELL GENERAL OBLIGATION BONDS AND NOTES OF THE CITY IN THE AGGREGATE PRINCIPAL AMOUNT OF $\$ 90,000,000$ FOR THE PUBLIC PURPOSES OF CONSTRUCTING AND RECONSTRUCTING ROADS AND STREETS; CONSTRUCTING, RECONSTRUCTING, AND IMPROVING SIDEWALKS, BIKEWAYS, AND OTHER BICYCLE AND PEDESTRIAN MOBILITY INFRASTRUCTURE; IMPROVING TRAFFIC SIGNAL SYNCHRONIZATION AND CONTROL SYSTEMS; ACQUIRING AND INSTALLING TRAFFIC SIGNALS; CONSTRUCTING, RECONSTRUCTING, AND IMPROVING DRAINAGE FACILITIES RELATED TO THESE IMPROVEMENTS; FUNDING DESIGN AND ENGINEERING FOR ROADS, STREETS, DRAINAGE, TRAFFIC SIGNAL, SIDEWALKS, BIKEWAYS, AND OTHER BICYCLE AND PEDESTRIAN MOBILITY INFRASTRUCTURE; AND ACQUIRING LAND AND INTERESTS IN LAND AND PROPERTY NECESSARY FOR THESE IMPROVEMENTS; WITH THE BONDS AND NOTES TO BE ISSUED IN ONE OR MORE SERIES OR ISSUES, TO MATURE SERIALLY OR OTHERWISE AND BEAR INTEREST AT A RATE OR RATES NOT TO EXCEED THE RESPECTIVE LIMITS PRESCRIBED BY LAW AT THE TIME OF ISSUANCE, AND TO BE SOLD AT THE PRICE OR PRICES AS THE CITY COUNCIL DETERMINES AND SHALL THERE BE LEVIED AND PLEDGED, ASSESSED, AND COLLECTED ANNUALLY AD VALOREM TAXES ON ALL TAXABLE PROPERTY IN THE CITY IN AN AMOUNT SUFFICIENT TO PAY THE ANNUAL INTEREST ON THE BONDS AND NOTES AND TO PROVIDE A SINKING FUND TO PAY THE BONDS AND NOTES AT MATURITY?


PART 2. The Proposition will appear on the official ballot in substantially the following form:
