ORDINANCE AMENDMENT REVIEW SHEET

Amendment: C2O-2010-010

Description:

Conduct a public hearing and consider an ordinance to limit the number of owner- and Historic Landmark Commission-initiated historic zoning cases to 3 per month, and to limit the number of owner- and Historic Landmark Commission-initiated historic zoning cases on properties located within National Register or Local Historic Districts to 1 per month each unless agenda slots remain otherwise open.

Background:

The Council passed Resolution No. 20100610-029 on June 10, 2010 directing the City Manager to process the above-described amendments to the City Code in conference with the Historic Landmark Commission and Planning Commission and present recommendations to Council by August 5, 2010.

Board and Commission Actions:

The Operations Committee of the Historic Landmark Commission met on June 16, 2010 and June 21, 2010 and presented recommendations to the Commission meeting on June 28, 2010. The Landmark Commission ratified the recommendations of the Operations Committee, but directed the Operations Committee to make further refinements to the recommendations. The Operations Committee met again June 30, 2010, July 14, 2010, and July 19, 2010 and presented final recommendations at the Historic Landmark Commission meeting on July 26, 2010.

The Codes and Ordinances Committee of the Planning Commission reviewed the recommendations of the Historic Landmark Commission on July 20, 2010. Staff presented the recommendations to the Zoning and Platting Commission on July 20, 2010 and received comments. The Planning Commission reviewed the proposed amendments and made recommendations on July 27, 2010.
