

## **M/WBE Summary**

Bid documents were distributed to 11 general contractors. Bids were opened on July 1, 2010. Excel Construction Services, L.L.C. submitted the lowest of three bids received:

The contractor's choice of work methodology provides for 7 areas of subcontracting opportunities which are listed below. Project participation goals stated in the solicitation were **2.65%** MBE and **1.63%** WBE. Total participation estimated on base bid amount of \$309,000:
