## ORDINANCE NO. 20101028-054


#### Abstract

AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 3306 EAST $5^{\text {TH }}$ STREET IN THE GOVALLE NEIGHBORHOOD PLAN AREA FROM COMMUNITY COMMERCIALNEIGHBORHOOD PLAN (GR-NP) COMBINING DISTRICT TO COMMUNITY COMMERCIAL-MIXED USE-CONDITIONAL OVERLAY (GR-MU-CO-NP) COMBINING DISTRICT FOR TRACT ONE AND FROM FAMILY RESIDENCENEIGHBORHOOD PLAN (SF-3-NP) COMBINING DISTRICT TO FAMILY RESIDENCE-CONDITIONAL OVERLAY-NEIGHBORHOOD PLAN (SF-3-CONP) COMBINING DISTRICT FOR TRACT TWO.


## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base districts on the property described in Zoning Case No. C14-2010-0014, on file at the Planning and Development Review Department, as follows:

Tract One: From community commercial-neighborhood plan (GR-NP) combining district to community commercial-mixed use-conditional overlay-neighborhood plan (GR-MU-CO-NP) combining district.

A 0.581 acre tract of land, more or less, out of Outlot 15, Division A, City of Austin, Travis County, the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance, and

Tract One: From family residence-neighborhood plan (SF-3-NP) combining district to family residence-conditional overlay-neighborhood plan (SF-3-CO-NP) combining district.

A 0.465 acre tract of land, more or less, out of Outlot 15, Division A, City of Austin, Travis County, the tract of land being more particularly described by metes and bounds in Exhibit " B " incorporated into this ordinance (the "Property"),
locally known as 3306 East $5^{\text {th }}$ Street, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "C".

PART 2. Except as specifically provided in Part 3 and Part 4 of this ordinance, the Property may be developed and used in accordance with the regulations established for the respective base districts, the mixed use combining district, and other applicable requirements of the City Code.

PART 3. The Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:

A site plan or building permit for the Property may not be approved, released, or issued, if the completed development or uses of the Property, considered cumulatively with all existing or previously authorized development and uses, generate traffic that exceeds 2,000 trips per day.

PART 4. The Property is subject to Ordinance No. 030327-11a that established the Govalle neighborhood plan combining district.

PART 5. This ordinance takes effect on November 8, 2010.

THENCE North $67^{\circ} 11^{\prime} 20^{\prime \prime}$ West along the south line of the herein described tract and north line of $5^{\text {th }}$ Street, a distance of 78.17 feet to a $1 / 2$ inch iron rod found marking the southeast corner of a 0.346 acre tract conveyed to Teresa Saldana in Document No. 2003233002 of the Official Public Records of Travis County, Texas, for the southwest comer of this tract;

THENCE North $23^{\circ} 20^{\prime} 16^{\prime \prime}$ East along the west line of this described tract and east line of said 0.346 acre tract a distance of 143.58 feet to a $1 / 2 "$ iron rod found marking the northeast comer of said 0.346 acre tract and southeast comer of Lot 10 , Block 2 of The Pipkin Addition recorded in Book 4, Page 86, of the Plat Records of Travis County, Texas, for an angle corner of this tract;
