**ORDINANCE NO.**

**AN ORDINANCE ANNEXING, FOR FULL PURPOSES, ADDITIONAL TERRITORY ADJACENT TO THE CITY LIMITS OF THE CITY OF AUSTIN REFERRED TO AS THE “SPRINGWOODS OUTPARCELS ANNEXATION AREA,” CONSISTING OF APPROXIMATELY 2 ACRES OF LAND OUT OF THE HENRY RHODES SURVEY, ABSTRACT NO. 522, IN WILLIAMSON COUNTY, TEXAS; AND APPROVING A SERVICE PLAN.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The Council finds that:

- 12 (A) Notice of the two public hearings concerning annexation of the territory  
13 described in Exhibit A was published in a newspaper of general circulation in  
14 the City of Austin and in the area to be annexed, and on the City of Austin  
15 internet website.
- 16 (B) The public hearings were held on September 23, 2010 at the Austin City Hall,  
17 301 West 2<sup>nd</sup> Street, Austin, Texas and September 30, 2010 at the George  
18 Washington Carver Museum & Cultural Center, 1165 Angelina Street, Austin,  
19 Texas.
- 20 (C) The public hearings were concluded after providing an opportunity for all  
21 persons present to be heard with respect to the proposed annexation. A  
22 proposed Service Plan was made available and explained at the public hearings  
23 required by state law.
- 24 (D) The annexation, for full purposes, of the territory described in Exhibit A serves  
25 the interest of the current and future residents of the City of Austin.
- 26 (E) All procedural requirements imposed by state law for the full purpose  
27 annexation of the territory described in Exhibit A have been met.

**PART 2.** The present boundary limits of the City are amended to include the following territory which is within the extraterritorial jurisdiction and adjacent to the city limits of the City of Austin in Williamson County, Texas, and which is annexed into the City for the full purposes:

32 Two tracts of land containing 1.9 acres of land, more or less, the tract hereinafter  
33 described as Tract One containing approximately 0.7 acre of land out of the Henry  
34 Rhodes Survey, Abstract No. 522 in Williamson County, Texas, and the tract

1 hereinafter described as Tract Two containing approximately 1.2 acres of land out  
2 of the Henry Rhodes Survey, Abstract No. 522 in Williamson County, Texas, said  
3 1.9 acres of land, more or less, being more particularly described in Exhibit A.

4 **PART 3.** The Service Plan attached as Exhibit B is approved as the Service Plan for the  
5 area.

6  
7 **PART 4.** The City Council declares that its purpose is to annex to the City of Austin  
8 each part of the area described in Exhibit A as provided in this ordinance, whether any  
9 other part of the described area is effectively annexed to the City. If this ordinance is  
10 held invalid as to any part of the area annexed to the City of Austin, that invalidity does  
11 not affect the effectiveness of this ordinance as to the remainder of the area.

12  
13 If any area or lands included within the description of the area set out in Exhibit A are:  
14 (1) presently part of and included within the general limits of the City of Austin; (2)  
15 presently part of and included within the limits of any other city, town, or village; or (3)  
16 are not within the jurisdiction or power of the City of Austin to annex, then that area is  
17 excluded and excepted from the area annexed.

19 **PART 5.** This ordinance takes effect on December 31, 2010.
