

M/WBE Summary

Bid documents were distributed to 17 general contractors. Bids were opened on August 26, 2010. The bid documents included an alternate bid item, which will be included in the contract. BRH-GARVER CONSTRUCTION, LP. submitted the lowest bid of 8 bids received:
