Subject: Watershed Protection Department FY 2012 Proposed Budget

Recommendation

1. The Environmental Board recommends approval with conditions of the WPDR FY 2012 Proposed Budget as presented to the Environmental Board FY12 Budget Subcommittee.
2. The Board recommends proposed funding for the following positions:
 - a. Landscape Architect II to assist with reduction of the backlog of 112,000 feet of stream erosion;
 - b. Engineer B to be part of the team that is performing comprehensive value-engineering reviews of CIP projects;
 - c. Engineering Associate C to conduct pond safety inspections on dam inventory;
 - d. Truck Driver to support Lady Bird Lake maintenance activities involving removal of over 250 tons of debris from the lake;
 - e. Street & Drainage operations Superintendent to provide development and implementation of operation and maintenance plans, including those for Waller Creek Tunnel;
 - f. GIS Technician for maintenance of critical GIS datasets, including storm drains, water quality ponds and Critical Environmental Features related to multiple CIP projects.
3. The Board supports the efforts of the Watershed Protection Department to streamline and to reduce costs related to the work of the Department, including:
 - a. The overall reduction of \$.9M from \$65.1M in FY 11 for a total of: \$64.2M in FY12,
 - b. The reduction of \$3M in funds transferred to CIP, understanding that it will affect the speed with which projects can be completed, and
 - c. The decision not to increase the Drainage Utility Fee for FY12 because of the downturn in the economy.
4. The Board recommends that the Department leverage, to the greatest extent possible, relationships with local community non-profit organizations, (e.g., American Youth Works, Tree Folks, Greenbelt Guardians & Austin Parks Foundation) to maximize the environmental learning potential, the tangible environmental benefits these types of organizations bring to

the Austin environment (i.e., re-vegetation of stream banks, invasive species removal, tree planting, etc.), and the reduction in costs to the City of Austin in accomplishing these tasks.

Rationale

The Watershed Protection Department has made a considerable effort to streamline and to reduce costs associated with the work of the department. The Director and staff decided not to request an increase in the Drainage Utility Fund fee for FY12 because of the financial strain being experienced by the citizens of Austin of the ongoing downturn in the economy. The Board commends the Department for this effort.
