

ORDINANCE NO. 81 0305-D

AN ORDINANCE APPOINTING ELECTION OFFICIALS TO CONDUCT THE MUNICIPAL ELECTION TO BE HELD APRIL 4, 1981; PROVIDING COMPENSATION FOR THE ELECTION OFFICIALS; DESIGNATING THE UTILIZATION OF AN ELECTRONIC VOTING SYSTEM FOR SAID ELECTION; DESIGNATING A CENTRAL COUNTING STATION FOR SAID ELECTION; ESTABLISHING A DATE FOR A PRECOUNT TEST OF THE AUTOMATIC TABULATING EQUIPMENT; PROVIDING NOTICE OF SAME; DIRECTING THAT AN INSTRUCTION SCHOOL FOR ELECTION OFFICERS SHALL BE CONDUCTED; PROVIDING NOTICE OF SAME; PROVIDING FOR SUCH OTHER ASPECTS AS ARE INCIDENT AND RELATED TO THE PURPOSE OF THIS ORDINANCE; SUSPENDING THE RULE REQUIRING THE READING OF AN ORDINANCE ON THREE SEPARATE DAYS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

SECTION 1. The following persons are hereby appointed Presiding Judges and Alternate Judges. Compensation for their services shall be \$3.00 per hour. Said election officials shall perform election duties for the Municipal Election to be held April 4, 1981, in accordance with the laws of the State of Texas, at the respective precincts:

SECTION 2. An electronic voting system, as the term is defined in Article 7.15, Texas Election Code, shall be utilized in connection with said election. Said system shall be utilized for all absentee voting as well as for all precinct voting conducted on election day. Ample voting equipment shall be provided. The Central Counting Station is designated as the City of Austin Central Data Center located on the second floor of the Municipal Building, 124 West 8th Street. The appropriate City administrative forces shall conduct at 6:00 p.m., April 4, 1981, a precount test of the automatic tabulating equipment; said test to be conducted in the Central Data Center on the second floor of the Municipal Building and in accordance with the provisions of the Texas Election Code. The City Clerk is directed to publicate notice of said test at least 48 hours prior thereto. The appropriate City administrative forces shall conduct an instruction school for election officers, said school to be conducted in the auditorium room of the City of Austin Electric Building, 301 West Avenue, said school to be open to any interested person and notice of said school shall be given to the public press at least 48 hours before it is held.

SECTION 3. The following persons are appointed in the capacities indicated to perform election duties for the conduction of said election, in accordance with the laws of the State of Texas at the prime, and if necessary the alternate, Central Counting Stations:
