

**SPECIAL REPORT OF EXPENDITURES
NOT BY A CANDIDATE**

This report is for persons (as defined at Section [2-2-2\(17\) of the City Code](#), which includes corporations) other than candidates or campaign committees who make one or more independent expenditures (as defined at [Section 2-2-2\(10\) of the City Code](#)) that in the aggregate exceed \$500 for the purpose of promoting the election or defeat of any candidate or candidates, or ballot measure, in a city election. This report must be filed:

- No later than the *5th business day after the date of the expenditure*, if the expenditure is made before the 60th day before the date of the election.
- No later than the *2nd business day after the date of the expenditure*, if the expenditure is made on or after the 60th day before the date of the election and before the 9th day before the date of the election.
- No later than *5pm on the 1st business day after the date of the expenditure*, if the expenditure is made on or after the 9th day before the date of the election.
