This request for authorization provides for additional funding which will be evenly distributed among eight firms to allow for continuation of new assignments while waiting for the new replacement rotation list to be executed which is not expected until late 2014.

On April 11, 2013, eight firms were selected for the 2013 General Architectural Services Rotation List with a total authorization amount of \$4,000,000. This rotation list was established to provide architectural services for small to

medium sized projects of a general or routine scope, and for projects having a critical or emergency schedule which would preclude going through the normal individual project Request For Qualifications (RFQ) selection process. To date, eight firms have received assignments for an estimated total of \$3,920,539.61.

An additional \$800,000 in authorization is required to allow the continuation of new assignments.
