### **ANALYSIS / ADDITIONAL INFORMATION:**

This contract provides for the purchase of one new brush truck body, crane, and grapple for the Watershed Protection Department. The brush body will be mounted on a heavy-duty International cab and chassis previously purchased. The brush-handling trucks are used to clean and remove brush and debris from the City of Austin waterways. The crane has an extended reach and is equipped with a heavy-duty refuse grapple used to pick up, remove, and deposit the debris into the dump body of the truck.

Fleet Services and the Office of Sustainability have worked together to develop a vehicle purchasing process to progress towards our citywide objective of obtaining carbon neutrality by 2020. The purchasing criteria incorporate pollutant and greenhouse gas emissions impact, available technologies on the market, physical demands on the vehicle, service application, and life-cycle cost. These criteria are applied to all vehicle purchase requests submitted to Fleet.

The vehicles and equipment in this RCA has been recommended for purchase utilizing a process that involves the Fleet Officer, affected Department Directors, and Assistant City Managers (ACMs). ACM approval is required for all new additions to the City's fleet prior to any requests being made to the Purchasing Office.
