Prior Council Action:	September 26, 2013 - Council approved Resolution No. 20130926-077, directing the City Manager to hold a community meeting to solicit suggestions and ideas with options for the future use of the tract located at 401 West St. Johns Avenue, including reconfiguring the site to allow public park use, a storm water pond and continued youth sports activities. November 19, 2009 - Council approved Resolution No. 20091119-068, directing the City Manager to adopt policy goals for urban parks, with one goal being that all residents living in the urban core will live within 1/4-mile walking distance of a publicly-accessible and child-friendly park or green space.

<p>In 2009, Council passed Resolution No. 20091119-068 with a goal that all residents living in the urban core will live within ¼-mile walking distance of a publicly-accessible park. This goal was later adopted in the Imagine Austin Comprehensive Plan. Furthermore, Council directed the City Manager, per Resolution No. 20130926-077, to hold a community meeting to solicit suggestions and ideas on future use of the 401 West St. Johns to property owned by the City, with questions including reconfiguration of the site to allow public park use, a storm water pond, and continued youth sports activities. One of the challenges of the 401 West St. John's site is visibility and access to West St. Johns Avenue. The existing City of Austin property has a narrow entry point and poor visibility to West St. Johns Avenue. This proposed acquisition would widen the access point to the property, alleviating these challenges.</p> <p>The Parks and Recreation Department will fund this proposed acquisition through parkland dedication funds.</p>
