The contract is for the one-time purchase of 200W light-emitting diode (LED) streetlights. The street lights will be purchased to replace existing street lights along 6th Street from IH 35 to Brazos Street. These new lights will have the ability to be dimmed or brightened to assist with crowd control and enhance pedestrian safety.

The purchase of these streetlights is in accordance with Council Resolution No. 20140925-081 directing the City Manager to engage stakeholders and City departments to ensure that the Downtown Entertainment District is a "safe and vibrant environment" and to report back with recommendations for any code changes to address the issues that the City Manager identifies.
