Authorize execution of a 36-month contract with MG LIMON CORPORATION DBA LIMON CONSTRUCTION to provide trucking and hauling services in an amount not to exceed \$1,510,026 with three 12-month extension options in an amount not to exceed \$503,342 per extension option, for a total contract amount not to exceed \$3,020,052.

Amount and Source of Funding

Funding in the amount of \$353,342 is available in the Fiscal Year 2015 -2016 Operating Budget of the Public Works Department. Funding in the amount of \$150,000 is available in the Fiscal Year 2015 -2016 Operating Budget of the Watershed Protection Department. Funding for the remaining 24-months of the original contract period and extension options are contingent upon available funding in future budgets.

Additional Backup Information

The contract will provide trucking and hauling support to supplement the City's existing fleet of trucks. The service will be utilized on street repaving, rehabilitation, and reconstruction projects to haul hot mix asphalt concrete, construction materials, and/or asphalt millings produced within the city limits.

The new contract offers various truck sizes, allowing the City the flexibility to meet the needs of any particular project. Without this contract, the City cannot perform concurrent major street projects in a timely, reliable manner. Jobs will be delayed creating conflicts with residents and adjacent businesses and targeted set service plans will not be met.

PRICE ANALYSIS

- a. Adequate competition
- b. 285 notices were sent including 32 MBEs and 11 WBEs. Four bids were received including two MBEs and one WBE.
- c. The pricing offered represents a 0% increase the last purchase made November 2012 of one line item. This is the first purchase of the other four lines, so pricing history is unavailable.
