Additional Backup Information	

A Sanitary Sewer Evaluation Study is a systematic inspection of sections of the sanitary sewer system to locate problems in wastewater piping. This project will perform a targeted Sanitary Sewer Evaluation Study of the Crosstown Tunnel Basin and will begin with a review and analysis of existing flow meter data to identify targeted sub-basins for additional study. Once identified, the targeted sub-basin studies will be reviewed to assess, identify, quantify, and prioritize repairs that will reduce Inflow and Infiltration, Sanitary Sewer Overflows, and minimize the possibility of future system failures and environmental impacts.

For this Sanitary Sewer Evaluation Study the selected consultant will provide the following services:

- Civil Engineering;
- Project Management;
- Investigation;
- Analytical Study;
- Field Services;
- Evaluation;
- Hydraulic Modeling;
- Coordination;
- Preparation of maps;
- Flow Monitoring;
- Evaluation of historical data;
- Preliminary Engineering and other engineering services as necessary.

This authorization provides for funding of professional services related to targeted as well as other activities to complement Austin Water's Capacity Management Operations and Maintenance. Specifically, the selected consultant will perform inspections, testing, system analysis and rehabilitation, repair cost estimates, and create a Preliminary Engineering Report prioritizing projects as a result of the Sanitary Sewer Evaluation Study Report.

This request allows for the development of an agreement with the qualified responder that Council selects. If the City is unsuccessful in negotiating a satisfactory agreement with the selected responder, negotiations will cease with that provider. Staff will return to Council so that Council may select another qualified responder and authorize contract negotiations with that provider.
