ORDINANCE NO. 020822-49

AN ORDINANCE AMENDING THE CITY CODE BY ADDING A NEW SECTION 16-4-20 PROVIDING FOR A MAXIMUM SPEED LIMIT OF 35 MILES PER HOUR DURING CERTAIN TIMES; AND CREATING A SCHOOL ZONE ON NORTH LAMAR BOULEVARD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Chapter 16-4 of the City Code is amended to add a new Section 16-4-20 to read as follows:

§ 16-4-20 MAXIMUM SPEED OF 35 MILES PER HOUR DURING CERTAIN TIMES.


The maximum prima facie speed limit is 35 miles per hour on the following street when the posted sign indicating the speed limit is equipped with one or more flashing amber lights in operation or other traffic control device is erected giving notice, on those days when classroom instruction or other school activities are being conducted. Proof that a flashing amber light is in operation on any day shall constitute prima facie evidence that classroom instruction or other school activities are being conducted on that day.

(1) North Lamar Boulevard (Loop 275) north from mile point 3.398 (744 feet north of Oakbrook Trail) to mile point 3.725 (375 feet south of Little Oak Drive) (Brentwood Christian School).

PART 2. The Council waives the requirements of Sections 2-2-3 and 2-2-7 of the City Code for this ordinance.

PART 3. This ordinance takes effect on September 3, 2002.



§ 12-4-66 35 MILE PER HOUR SCHOOL ZONES.

On a day classroom instruction or another school activity is in session, the maximum prima facie speed limit is 35 miles per hour on the following streets:

- (1) Lamar Boulevard (North) (Loop 275) from 744 feet north of Oakbrook Trail (mile point 3.398) to 375 feet south of Little Oak Drive (mile point 3.725) (Brentwood Christian School).
- (2) Parmer Lane (F.M. 734) from 137 feet west of Metric Boulevard (mile point 4.226) to 211 feet west of Rampart Street (mile point 4.028) (Parmer Elementary School).

ARTICLE 5. SPEED LIMITS IN CONSTRUCTION ZONES.

Division 1. Temporary Construction Zone Speed Limits.

§ 12-4-81 TEMPORARY CONSTRUCTION ZONE SPEED LIMITS.

- (A) The temporary construction zone speed limits set by the traffic engineer are lawful, unless an increased or reduced speed is necessary for safe operation or in compliance with law.
- (B) A speed in excess of the temporary construction zone speed limits set by this article is prima facie evidence that the speed is not reasonable or prudent and that it is unlawful.

§ 12-4-82 DESIGNATION OF TEMPORARY CONSTRUCTION SPEED LIMIT.

(A) The traffic engineer may set a 90-day reduced speed limit for a construction zone if the traffic engineer determines that a special hazard that requires a lower speed limit to protect the public safety and welfare exists due to the construction.

§ 16-4-65 30 MILE PER HOUR SCHOOL ZONES.

On a day classroom instruction or another school activity is in session, the maximum prima facie speed limit is 30 miles per hour on the following streets:

- (1) Airport Boulevard (Loop 111) from 422 feet north of Gunter Street to 258 feet south of Goodwin Street (Govalle Elementary School).
- (2) Braker Lane (eastbound) from Plains Trail to 1000 feet east of Plains Trail (McBee Elementary School).
- (3) Congress Avenue (South) (Loop 275) from 469 feet north of the centerline of North Bluff Drive (mile point 18.452) to 375 feet south of the centerline of Eberhart Lane (mile point 18.654) (Pleasant Hill Elementary School).
- (4) Loyola Lane from 250 feet west of the west curbline of Johnny Morris Road to 50 feet east of the curbline of Sandshof Drive (Jordan Elementary School).
- (5) Manchaca Road (FM 2304) from 121 feet north of Gaines Mill Lane to 58 feet north of Malvern Hill Drive (Strickland Christian School).
- (6) Metric Boulevard from 250 feet south of Scofield Lane to 250 feet north of Scofield Lane (Parmer Lane Elementary School/Westview Middle School).
