Background

- Update to November 2, 2015 HHS Committee Meeting presentation
- HHSD FY 16 overall budget is \$85,227,151.
 \$61,282,968 of that is from the City General Fund
- City Council made significant new investments in public health and human services in FY 15-16
- City Council Resolution 20160128-068-Adopted 1/28/16
 - \$11,973,307 of additional funding for social service contracts
 - \$10,340,870 of additional funding for the Health and Human Services Department within 2-4 years.
 - 3% annual increase to existing social service and workforce development contracts
 - Annual increase for the HHSD proportionate to population growth

Improve Maternal, Child and Adolescent Health Results

Investment

FY15 \$2,168,552

FY16 \$2,572,630

Performance Measures

- Ensure 95% of women enrolled in WIC during pregnancy breastfeed their children
- Certify 68% of full time early childhood centers that serve at least 10% low income children are quality rated
- Establish 90% of children/youth served by contractors progress to next developmental/academic level
- Reduce the incidence rate of reported cases of measles, pertussis, mumps and rubella to 28 per 100,000



Improve Quality of Life to Reduce the Years of Potential Life Lost due to Preventable Chronic Diseases

• Investment FY15 \$ 926,741

FY16 \$2,596,117

Performance Measures

- Reduce the number of tobacco related deaths below 690 per year
- Ensure 85% of Quality of Life Initiative and public health nursing clients follow through with referrals to a health provider



Minimize Public's Exposure to Foodborne Illness

• Investment FY15 \$5,650,168

FY16 \$5,388,875

Performance Measures

Conduct 2 inspections per fixed food establishment annually

<u>Outcomes</u>

- Provide routine safety inspections for at least 60% of temporary establishments permitted.
- Review new commercial construction within 35 days



Minimize the Spread of Communicable and Infectious Diseases within the General Population

InvestmentFY15 \$3,307,437

FY16 \$3,948,212

Performance Measures

- Provide 100% of active tuberculosis patients with complete therapy in 12 months
- Arrange 90% of newly-diagnosed HIV positive clients linked to HIV related services with medical care
- Ensure 90% of STD clinic clients are examined, tested, and/or treated the same day.



Strengthen Public Health Infrastructure for Improved Health Results

Performance Measures

Provide over 42,230 birth and death certificates per year.

Achieve and maintain public health accreditation



Social Services

Assist People in Achieving Safety, Stability and Long Term Self-Sufficiency

• Investment FY15 \$27,771,626

FY16 \$30,367,055

Performance Measures

- Serve 62,500 unduplicated persons with basic needs by the Neighborhood Services activity.
- Serve 45,521 clients through social services contracts

- Ensure 30% of homeless persons residing in shelters will receive case management services.
- Ensure 75% of households served through City of Austin social service contracts maintain housing or transition into housing from homelessness.
- Certify 85% of clients enrolled in self-sufficiency case management report a reduction or elimination of income barriers.

Social Services Outcomes

Social Services Outcomes 2010 RFP (3.5 Years)

Basic Needs \$4,000,101

Outcome: 82.38% of households at risk for homelessness that maintain housing. (11,047 individuals maintained housing)

Behavioral Health \$748,756

Outcome: 85.56% of individuals met their treatment plan goals. (9276 individuals were successful)

Children and Youth \$1,978,019

Outcome: 86.75% children or youth progressed to the next developmental or academic level.

(29,336 individuals progressed)

Homeless \$1,649,474

Outcome: 80.60% of households served maintain housing or transition into housing from homelessness.

(16,728 individuals maintained or transitioned)

Workforce Development \$4,829,289

Outcome: 69.56% of individuals who maintain or increased income.

(4,702 individuals maintain or increase income)



Social Services Success Stories

- One agency provided 54 units of Permanent Supportive Housing using the Housing First model with a 70% retention rate and was successful in housing the hardest to serve: criminal histories, poor rental/utility histories, mental illness and addiction backgrounds.
- Since 1998 one of the programs has ensured over 1,040 participants entered the Central Texas workforce and last year had average starting wages of nearly \$40,000 a year, which is three times their annual earnings when they entered the program.
- A student was referred to a youth program for his "anti-social" behavior. After working
 with this agency his behavior changed, he got caught up with all of his course work
 and interacted positively with others. One of his teachers stated he was "the most
 changed senior."
- One client states "this agency gave me the tools for me to help myself and to seek help from other agencies in the community. They helped me to become a better wife to my husband by giving us the opportunity to take couples therapy and a better mother to my children with the Parents as Teachers program. In short, they have helped me to see that there is a future for me and my family.
