

## M/WBE Summary ☐ IDIQ Construction Contract

Solicitation documents for this Invitation for Bid were distributed to 287 contractors using the City's Vendor Connection web portal. 6 general contractors obtained the bid documents and 2 bids were received. Bids were opened on February 11, 2016. One out of two bids received was a certified MBE /WBE firm. Muniz Concrete & Contracting, Inc. submitted the lowest responsive bid of 2 bids received:

The contractor's choice of work methodology provides for 6 areas of subcontracting opportunities which are listed below.
