Authorize award and execution of a 12-month contract with EQUIPMENT DEPOT, to provide forklifts, in an amount not to exceed \$178,657, with three 12-month extension options in an amount not to exceed \$178,657 per extension option, for a total contract amount not to exceed \$714,628.

Amount and Source of Funding

Funding in the amount of \$89,329 is available in the Fiscal Year 2015-2016 Operating Budget of Austin Energy. Funding for the remaining six months of the original contract period and extension options is contingent upon available funding in future budgets.

Additional Backup Information

The contract will provide for the lease of seven forklifts to be used at various Austin Energy facilities. The forklifts will be used in warehouses for lifting heavy material onto storage shelves as well as moving heavy equipment such as transformers and switchgear inside downtown electrical vaults.

The contract will ensure that Austin Energy has the equipment to perform day to day operations in a timely matter. The current contract expires on August 6, 2016; however, the lead time for the new forklifts is 120 days. Approval is requested now to ensure there is no lapse in availability of forklifts.
