Set a public hearing to consider the use of dedicated parkland, known as Edward Rendon Sr. Metro Park at Festival Beach (District 3), for approximately 2,049 square feet of permanent access for operation and control of the Pedernales Substation as part of the Holly Street Power Plant Decommissioning and Demolition Project, in accordance with Chapter 26 of the Texas Parks and Wildlife Code. (Suggested date and time: May 5, 2016 at 4:00 p.m., Austin City Hall, Council Chambers, 301 West Second Street, Austin, TX.)

All costs associated with construction, as well as any parkland restoration, will be paid by requester.

Additional Backup Information			

On May 2, 1985, the City Council of the City of Austin approved Ordinance No. 850502-U dedicating certain City-owned land along or near Lady Bird Lake as parkland. Included in the ordinance was the "Holly Street Power Plant and adjacent land used in connection therewith." Part three of the ordinance states "tracts of land shall immediately become parkland upon the termination or cessation of their existing use". As part of the Holly Street Power Plant Decommissioning and Demolition project, Austin Energy (AE) will be ceasing its use of various tracts of land for utility purposes. Those tracts of land will be turned over to the Parks and Recreation Department for use as public parkland. In order to maximize the highest and best use for these tracts, the Parks and Recreation Department has collaborated with the community through a series of public meetings to propose open play areas and the realignment of the existing hike and bike trail in order to locate the trail closer to Lady Bird Lake. AE will retain the land needed for the continued operation of the existing Pedernales Substation.

Due to the reconfiguration of public access to the 11.244 acres of new parkland, AE will require the use of a 0.0470-acre tract that is currently parkland located at the northeast end of Edward Rendon Sr. Metro Park at Festival Beach, at the end of Riverview Street to provide permanent access to the Pedernales Substation for its operations and maintenance requirements.

Chapter 26 of the Texas Parks and Wildlife Code provides that the use of parkland for non-park purposes may be approved upon a finding that there is no feasible and prudent alternative to the use of this land and that the project includes all reasonable planning to minimize harm to the land.

There is no feasible and prudent alternative to the use of the dedicated parkland which includes all reasonable planning to minimize harm to such lands. The dates of public notification in the *Austin American-Statesman* are April 10, 17 and 24, 2016.
