The contract with Whelan Security Company, Inc. is to provide unarmed security guard and patrol services at multiple Austin Water (AW) sites, seven days per week, including holidays. The Contractor provides 24-hour unarmed security guard services, as well as unarmed roving security services at selected locations. In addition, unarmed patrol guards will be required to perform mobile monitoring and investigation of alarm activations at various other AW sites throughout the City.

The contract was awarded through the competitive process on January 17, 2013, in an amount not to exceed \$2,238,264 for the initial 24-month contract period with two 24-month extension option periods in an amount not to exceed \$2,238,264 per extension option. There are two guards assigned to Waller Creek Center that currently operate the security operations center on a 24-hour, seven day a week basis. The security operation center is located on the 9th floor of the building.

On December 11, 2014, Amendment 1 was approved to add an additional unarmed security guard to the lobby between the hours of 6:00 AM to 6:00 PM, Monday through Friday while the doors to the facility are unlocked and City observed holidays. The contract was amended to increase the two 24-month extension option periods by \$99,786 each, changing the not to exceed amount on the contract to \$6,914,364.

This amendment is being requested to increase the contract to accommodate for a 7.9% increase in labor costs supported by the Bureau of Labor Statistics. The amendment will also provide 5 additional security posts at AW locations, to monitor access into secure sites and provide increased security coverage.

If the City is unable to amend this contract, the current contract will no longer have sufficient funding and will terminate early. This contract is necessary for the protection of public drinking water.
