

Challenges of Every Austin Citizen




Demographic Trend

An increasingly sharp edge of affluence

- Increasingly hard edge between affluent central Texas and less-than-affluent parts of the urban region
- Austin's center of wealth has slowly migrated west of the city
- Greater burden for citizens funding services and facilities that are used and enjoyed by individuals from across the region
- Austin is becoming a more divided city



➤ Other programs


- Renter Assistance: Provides housing assistance to eligible low-income renters
- Social Services Contracts and Neighborhood Centers Assistance: Programs to assist individuals and families transition from homelessness to housing and to maintain housing
- Rental Housing Developer Assistance: Programs to assist creation of new affordable rental housing through financial assistance and Developer Incentives

Housing Assistance

City programs to mitigate or offset costs

➤ Permanent Supportive Housing (PSH)

- Resolution approved March 2010
- 350 Units by 2014 (achieved in October 2014)
- 2nd Resolution approved in Fall 2014
- New goal is 400 more PSH units
- Unmet need of ~ 1000 PSH Units
- Investing in PSH results in a cost avoidance incurred in other areas such as healthcare and public safety
- 209 Units of PSH have a 96% retention rate
- Clients are either in a PSH unit or exited to other permanent housing



Transportation

City programs to mitigate or offset costs

- HHSD provides transportation vouchers for taxis to assist clients to access key services including HIV/STD Clinic, WIC, and other services
- HHSD neighborhood centers provides bus passes to assist individuals and families that meet eligibility requirements with basic needs services
- PARD provides door-to-door transportation services for seniors age 60 and older residing within the Austin city limits

Employment

City programs to mitigate or offset costs

- Job searches
- Resume development and critiquing

➤ Living Wage policies (ordinances)

- 20160519-011 – Apply living wage to seasonal life guards
- 20160324-020 – Apply living wage to non-construction related solicitations
- 20160324-015 – Apply living wage to City Projects
- 20150910-BUD001 – Establish a new living wage of \$13.03/hour for temporary staff

Child Care

City programs to mitigate or offset costs

- HHSD and NHCD funded child care programs
 - Child care subsidies to low income families with parents either working or in a training program or in crisis such as homelessness
 - Out of School free time programming
 - Afterschool and summer care for Head Start families for working families

Child Care

City programs to mitigate or offset costs

➤ PARD Out-of-School Programs

- Subsidizes the cost of after-school programs and summer camp 50% for all Austin residents
- In addition to the existing subsidization all participants that qualify for financial aid receive an additional 50% discount
- The Scott Johnson scholarship further discounts enrollment fees by nearly 90%
- PARD operates free, semi-structured programs for youth at strategic locations during the summer months
- In addition, youth have free access to drop-in activities in recreation centers during hours of operation

Food

City programs to mitigate or offset costs

- HHSD food assistance programs
 - Women Infant and Children (WIC) clinics
 - Fresh Food For Families distribution
 - Supplemental Food Nutrition Program enrollment outreach
 - Healthy Options for Elderly
- PARD food-provision partnerships
 - Kid's Café program prepares free hot meals to youth ages 18 and under at 3 locations with commerical kitchens
 - Free snacks and meals at 7 playground sites, 13 summer camps and 10 afterschool locations
 - Weekend Backpack Program at Summer Camp and Playground sites
 - Through the congregate meals program, PARD provides free well-balanced meals to adults over the age of 60 at eight area locations

Health Care

City programs to mitigate or offset costs

- Affordable Care Act enrollment outreach
- HHSD public health services
 - Immunizations clinics for adults and children
 - HIV/STD/TB clinic
 - Refugee clinic
 - Free community-based health screenings and education programs
- PARD offers free access to gymnasiums, pools, fitness and weight rooms, community gardens, and health promotions programs
- Clinic Services at Turner Roberts Recreation Center

Success Stories

Helping those that need it

➤ Neighborhood Centers

- Presenting challenges: affordable housing, food, clothing, school supplies for their children, transportation and employment assistance.
- Collaboration: Workforce Solutions for employment assistance
- Results: Both parents secured gainful employment and stable affordable housing. Children doing well in school

➤ Best Single Source Plus (BSS+)

- Presenting challenges: Recently evicted, large debt, criminal history and missing necessary documentation such as birth certificate.
- Collaboration: Foundation Communities for affordable housing. Best Single Source
- Results: Family secured housing, worked and saved money to pay off their debt. Children doing well in school

Building the Bridge

Affordability to Equity

- As Austin grows and costs increase, the need for services expands to more people
- Responsibility to ensure there is equal access of city programs for all
- City has initiatives to ensure access of services exist for those that need it
- Austin remains livable by providing equal access to the programs offered

Equity

Initiatives Undertaken or Underway

➤ CitizenQuality of Life Initiatives

- Purpose is to assess the overall experience of Austin's diverse communities and level of awareness and access to City services
- African American QOL report was finalized April 2008; Hispanic QOL report in June 2013; Asian American QOL study on-going
- Work continues through Boards and Commission of each initiative

➤ Survey

- Provides the City an opportunity to assess service levels and satisfaction by district

Equity

Initiatives Undertaken or Underway

➤ Digital Inclusion

- The Digital Inclusion Strategy serves as a roadmap for addressing access and adoption of digital technology in Austin
- Every Austin resident having an opportunity to be fully engaged in digital society, accessing and using digital and communications technology

➤ Planning and Zoning's Neighborhood Assistance Center

- The Neighborhood Assistance Center assists citizens involved in neighborhood associations, homeowners associations and other self-defined neighborhood organizations shape their neighborhoods

Equity

Initiatives Undertaken or Underway

- Health programs for targeted communities
 - Contracts
 - Quality of Life Expansions
- Equity Office
 - Currently conducting town hall meetings; first one tonight
 - Opportunities for citizens to offer their feedback on what they envision for the Equity Office
- Equity Tool
 - Establish best practices criteria, definitions, and instructions for completing a Racial Equity Impact Analysis
 - To be developed after Chief Equity Officer has been hired
 - Will involve robust community input
