

M/WBE Summary □ IDIQ Construction Contract

Public notice was given for this solicitation, CLMC594 the Annual Asphalt Repair 2016 IDIQ, through the City's Vendor Connection web portal which resulted in 315 contractors receiving notification. Five contractors obtained the bid documents and two bids were opened May 5, 2016. One of two bids received was from a certified MBE firm. Alpha Paving Industries, LLC submitted the lower responsive bid of the two bids received:
