

M/WBE Summary

Public notice was given for this solicitation, CLMC590 Lost Creek 1 and 2 Reservoir Improvements, through the City's Vendor Connection web portal which resulted in 297 contractors receiving notification. Three contractors obtained the bid documents and three bids were received and opened on May 5, 2016. None of the bids received were from MBE/WBE certified firms. Blastco Texas, Inc. submitted the lowest responsive bid of three bids received including a \$50,000 allowance:
