AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES, WAIVING CERTAIN REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED AUSTIN SYMPHONY JULY 4TH CONCERT AND FIREWORKS EVENT TO BE HELD ON JULY 4, 2016.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The City co-sponsored Austin Symphony July 4th Concert and Fireworks event will be held on Saturday, July 4, 2016 at Auditorium Shores.
