This project will reconstruct Justin Lane from Burnet Road to Reese Lane and includes full depth street reconstruction, new and replacement sidewalks, sidewalk ramps, new and replacement curbs and gutters, replacement of approximately 7,480 linear feet of deteriorated 6-inch water mains with 12-inch water mains, and a new storm sewer.

In addition to the above work and to enhance the mobility and safety along the corridor for all users, per City Ordinance No. 20141106-118 (the Austin Bicycle Plan), a two-way protected bicycle lane will be installed on the north side of Justin Lane from Burnet Road to North Lamar Boulevard. Protection for the two-way bikeway will include reflective traffic buttons along with a parking lane on the south side of the street.

This project is tentatively scheduled to begin in October 2016 and be substantially completed October 2017. Public communication to the affected area has been continuous through a combination of meetings, mailings, and a website. This item is not time sensitive, however this project will improve mobility and safety in the area.

The allowance of \$150,000 will be used to address replacement of a sanitary service line in case of a conflict with the proposed storm sewer. An allowance is an amount that is specified and included in the construction contract or specifications for a certain item(s) of work whose details are not yet determined at the time of bidding.

Due to the potential for unseen conditions, a 5% contingency in funding has been included to allow for the expeditious processing of any change orders. A contingency is an additional amount of money added to the construction budget to cover any unforeseen construction costs associated with the project.

The contract allows 360 calendar days for completion of this project. This project is located within zip code 78757 (District 7). The project will be managed by the Public Works Department.

Facilities Rehabilitation, Inc., is located in Taylor, Texas.
