**Additional Backup Information**

This interlocal agreement provides funding to reimburse TXDOT for the relocation of existing City of Austin water lines that conflicted with TXDOT's improvements to the US 290 Intersections at FM 1826 and Convict Hill Road.

The Final Statement of Cost for the City of Austin's portion of the project is \$1,022,528.91 resulting in the need for an additional \$123,652.41. The additional cost was associated with various bid item quantity overruns including jacking and boring of 30-inch diameter steel casing, 6 inch ductile iron pipe, 8 inch diameter ductile iron pipe, 12 inch diameter ductile iron pipe, 16 inch diameter ductile iron pipe, 24 inch diameter ductile iron pipe, 16 inch by 16 inch wet connection, 6 inch diameter gate valve, 8 inch diameter gate valve, 12 inch diameter gate valve, fire hydrants and ductile iron fittings.

This amendment to the interlocal agreement provides for final payment and closeout of the TXDOT US 290 at FM 1826 and Convict Hill Road project.

The TXDOT project began construction in May 2013 and closed the project on March 4, 2016.

This project is located within zip code 78741 (Council District 8) and is managed by the Public Works Department.
