The contract will provide new transmitters, sensors and related equipment to detect toxic and explosive gases. The new equipment will replace old, obsolete and partially functioning gas detection equipment at various buildings at the South Austin Regional Wastewater Treatment Plant. Gas detection equipment is used to protect the health and safety of City staff and the public by allowing staff to detect harmful gases that may be leaked into the air from the treatment plant process areas. In addition, the contractor will provide onsite training for Austin Water employees at the South Austin Regional Wastewater Treatment Plant. The training will include calibration, operation and maintenance instructions, increasing the life and accuracy of the equipment.

If the City is unable to secure the contract, Austin Water will be less equipped to detect toxic and explosive gases, thereby exposing City staff and the public to health and safety risks.
