

## **M/WBE Summary**

Project specific subgoals stated in the solicitation were 2.91% African American; 5.14% Hispanic; 0.76% Native/Asian; and 2.56% WBE. The Contractor submitted a MBE/WBE Compliance Plan that met the goals of the solicitation and was approved by the Small and Minority Business Resources Department.

The contractor's choice of work methodology provides for 16 areas of subcontracting opportunities which are listed below. Total participation estimated on base bid amount of \$4,544,818:
