Subject

Approve an ordinance authorizing the acceptance of \$41,255 in grant funds from the U.S. Department of Health and Human Services, Health Resources and Services Administration, and amending the Fiscal Year 2016-2017 Health and Human Services Department Operating Budget Special Revenue Fund (Ordinance No. 20160914-001) to appropriate \$41,255 for the Ryan White Part A HIV Emergency Relief Project and Minority AIDS Initiative Grant Program for the provision of medical and supportive services to people with the human immunodeficiency virus.

Amount and Source of Funding

Funding in the amount of \$41,255 is available from the U.S. Department of Health and Human Services (DHHS), Health Resources and Services Administration (HRSA). The grant period is from March 1, 2016 through February 28, 2017. A City funding match is not required.

Additional Backup Information

On November 21, 2016, the City's Health and Human Services Department received a Notice of Grant Award from the U.S. Department of Health and Human Services for the Ryan White Part A HIV Emergency Relief Project and Minority AIDS Initiative (MAI) approving the requested carryover from Fiscal Year 2015-2016 in the amount of \$41,255. The current appropriation in the Fiscal Year 2016-2017 budget is \$4,794,000 and the additional \$41,255 in grant funds increase the operating budget for the Ryan White Part A grant to \$4,835,255.

The Austin Transitional Grant Area plan is to use the additional grant funds for direct HIV core and support services listed in attachment A.

Services are delivered by our Part A providers, which include the following: AIDS Services of Austin, Inc., Austin/Travis County Integral Care-C.A.R.E. Program, Community Action of Central Texas, Inc., Central Texas Community Health Centers-David Powell Community Health Center, Project Transitions, Inc., Waterloo Counseling

Center, Wright House Wellness Center.

The General Fund will not be required to contribute additional funds beyond those currently budgeted to this grant. When the grant funds expire, the HHSD's need for continuing funding will be evaluated and may be denied.
