Prior Council Action:	On December 15, 2016, Council approved Resolution No. 20161215-066 directing the City Manager to identify emergency funding for immigrant legal services. On March 31, 2016, Council approved agenda item 20160331-020 authorizing award, negotiation and execution of this agreement in response to Request for Applications No. HE2016RK for health equity services. On September 8, 2015, Council approved Ordinance No. 20150908-001 adopting the Fiscal Year 2015-2016 Operating Budget. On December 16, 2016, Council approved Resolution 20161215-066 directing the City Manager to work with City departments to identify emergency funding for immigrant legal services and outreach efforts with a goal of assisting 100 additional Austinites per month than are currently served, and to strongly consider expansion of existing contracts that could best perform these services as soon as possible.

Austin Public Health (APH) currently manages a social services contract with Catholic Charities of Central Texas (CCCTX) to provide immigrant legal services and counseling. This contract was awarded to CCCTX as a result of the APH solicitation in Fiscal Year 2015-2016 for health equity services. This contract was effective April 1, 2016 in the amount of \$100,000 for a 12-month term with five renewal options each in the amount of \$100,000. The program provides education through "Immigration 101" sessions at libraries and churches in the community, assistance in obtaining legal authorization to work in the United States and securing immigration status, and counseling services to immigrants previously involved in a traumatic experience.

CCCTX documentation indicates 50 additional client consultations per month would be served by hiring additional staff, adding appointment availability outside regular office hours, and increasing general operating funds to expand the services in their current contract.
