AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 4604 AND 4608 EAST HOWARD LANE FROM INTERIM-SINGLE-FAMILY RESIDENCE SMALL LOT (I-SF-4A) DISTRICT TO SINGLE-FAMILY RESIDENCE SMALL LOT (SF-4A) DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from interim-single-family residence small lot (I-SF-4A) district to single-family residence small lot (SF-4A) district on the property described in Zoning Case No. C14-2017-0035, on file at the Planning and Zoning Department, as follows:

All that certain tract or parcel of land out of and a part of the Mariguita Castro Survey Number 50, Abstract Number 160 situated in Travis County, Texas, said tract of land being more particularly described as being all of Tract 3A conveyed to Cantarra Ventures II, in Document Number 2015158593 of the Official Public Records of Travis County, Texas, said 48.812 acre tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),

locally known as 4604 and 4608 East Howard Lane in the City of Austin, Travis County, Texas, generally identified in the map attached as Exhibit "B".


