<p>For the past year, the City and Travis County (County) have discussed the creation and implementation of two pilot programs, the Basic Pet Enrichment and Training Program and the Kitten Fostering Program, enabling incarcerated individuals the opportunity to train animals from the City's Animal Center that would both provide an enriching experience for the animals and provide job skills to incarcerated individuals that could potentially enhance their success after release.</p> <p>The pilot programs will include both dogs and kittens and approval of this item will be for the Kitten Fostering Program. Animals will be vetted to ensure the enrollment of animals without a history of unprovoked minor bites, or a history of attacking humans or other animals. Subject to the City's approval, the County will establish a screening process for the selection of resident caretakers to confirm only incarcerated individuals without a history of violent crimes towards humans or animals will be considered.</p> <p>The City will sterilize, micro-chip, and provide food, medical treatment, and basic animal care to animals selected for the program. The City will also administer training curricula (six weeks for dogs and one day for kittens) to educate resident caretakers on the basics of the specific species' behavior, healthcare, and animal tendencies. The City will also conduct weekly pet health assessments, and transport animals before and after each training period.</p> <p>The County will ensure all resident caretakers treat pets humanely and appropriately while in their care and custody. Pets will be supervised at all times and resident caretakers will follow specific guidelines for animal-care provided by the City. The County will immediately contact the City if a pet is sick, injured, lost, stolen, gets loose, dies, or exhibits any remarkable change in behavior.</p>
