Authorize execution of an amendment to the construction contract with Alpha Paving Industries, LLC, for the Annual Asphalt Repair 2016 Indefinite Delivery/Indefinite Quantity project in the amount of \$750,000, for a total contract amount not to exceed \$3,750,000. (Note: This amendment will be awarded in compliance with City Code 2-9A [Minority Owned and Women Owned Business Enterprise Procurement Program]. Current participation to date is 97.84% MBE and 2.16% WBE).

Additional Backup Information:

This Annual Asphalt Repair Indefinite Delivery/Indefinite Quantity contract provides utility cut repair for selected neighborhood streets throughout Austin. The Public Works Department requests authorization to increase the contract amount to provide additional construction services for the removal of existing temporary asphalt repairs and their replacement with permanent Type C Hot Mix Asphalt Concrete.

Indefinite Delivery/Indefinite Quantity contracts provide for an indefinite quantity of services for a fixed time, usually an initial term with extension options. They are commonly used when precise quantities of supplies or services, above a specified minimum, cannot be determined. Indefinite Delivery/Indefinite Quantity contracts help streamline the contract process and service delivery and allow the City the flexibility to add work as needs arise or change. As each project is defined, a specific work assignment will be given to the contractor who will complete the scope of work for the unit prices included in the contract. Work deadlines are established for each work assignment.

The contract is currently in the last option term and scheduled to expire in June 2018. Due to a considerable backlog of streets requiring repair and a commitment by the contractor to hold current contract unit costs, it is advantageous for the City to allow for the completion of that work under the terms of this contract. This contract will not eliminate the backlog of street repairs, therefore an additional Indefinite Delivery/Indefinite Quantity contract for similar services will be solicited in the future.

This amendment has been approved by the City's Change Control Committee. The Change Control Committee was established to comply with Council Resolution No. 20120126-048, which required the establishment of consistent criteria and process to evaluate contractual changes for all contracts administered by the Capital Contracting Office. The Change Control Committee is comprised of management-level subject matter experts.

Alpha Paving Industries, LLC. is located in Round Rock, TX.
