

MWBE Summary

Public notice was given for this solicitation IFB 6100 CLMC677 Upper Boggy Creek Trail Phase 1, through the City's Vendor Connection web portal, which resulted in 1,133 contractors receiving notification and 82 contractors obtaining the bid documents. Four bids were received and opened on September 28th, 2017. Of the four of bids received one bid was from MBE/WBE certified firm. MA Smith Contracting Co Inc. submitted the lowest responsive bid of four bids received:
