

MBE/WBE Summary

Public notice was given for this solicitation CLMC671 Burluson Road Pressure Conversion Phase 1, through the City's Vendor Connection web portal, which resulted in 519 contractors receiving notification and 78 contractors obtaining the bid documents. Seven bids were received and opened on September 21, 2017. Of the seven bids received three bids were from MBE/WBE certified firms.
