Authorize negotiation and execution of a contract through the State of Texas Department of Information Resources with Axon Enterprise, Inc., for body worn camera bundle systems and peripherals including ongoing maintenance, support, and storage, for up to 10 years for a total contract amount not to exceed $\$ 10,753,379$. (This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods and services required for this procurement, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

## Additional Backup Information:

The contract is for the purchase, implementation, and support of a limited number of wearable body cameras for the Austin Police Department (APD). Body worn cameras will allow APD officers to video and audio record their daily activities while on duty. This product will be capable of indexing video files using classifications, dates and times, officer identification and other data for retrieval. The contract also provides a warranty of all equipment as well as maintenance, upgrades, repair services, and cloud storage of all data. Body worn cameras will be refreshed or replaced at a minimum of every 24 months after each deployment. The contractor will remain compliant at all times with the requirements of the Federal Bureau of Investigation's Criminal Justice Information System regarding system and network security and personnel backgrounds as applicable.

This contract will provide for the purchase of approximately 1,200 camera bundle systems (includes hardware, continuous cloud storage, software licenses, and equipment maintenance and support), and peripherals.

The State of Texas Department of Information Resources (DIR) cooperative establishes competitively bid contracts that may be utilized by the State and other government agencies through a cooperative agreement. Cooperative agreements save taxpayer dollars by leveraging the State's volume-buying power to drive down costs on hundreds of contracts through a streamlined cooperative purchasing program.

The proposed contract is exempt from the competitive bidding requirements of Chapter 252 of the local government code as this is a procurement necessary to preserve or protect the health and safety of the municipalities'residents. §252.022(a)(2) Tex. Loc. Gov't. Code.

Delay in approving or failure to approve this contract will result in APD not being able to outfit officers with body worn cameras and will result in the loss of grant funding.
