**ANALYSIS / ADDITIONAL INFORMATION:** This budget amendment will accept \$82,200 in grant funds from the State of Texas, Office of the Governor, Criminal Justice Division, BG-Rifle-Resistant Body Armor Grant Program (BAGP) fo the Rifle-Resistant Body Armor Project for a 1-year grant period. Funding will allow the City to outfit an estimated 100 officers with NIJ-rated rifle resistant body armor. The General Fund will not be required to contribute additiona funds beyond those currently budgeted to this grant. When the grant funds expire, the Austin Police Department' need for continuing funding will be evaluated and may be denied.
