6 **AN ORDINANCE AUTHORIZING THE ACCEPTANCE OF FUNDS AND**  
7 **AMENDING THE FISCAL YEAR 2017-2018 AUSTIN TRANSPORTATION**  
8 **DEPARTMENT'S OPERATING BUDGET SPECIAL REVENUE FUND**  
9 **(ORDINANCE NO. 20170913-001) TO APPROPRIATE FUNDS FOR**  
10 **IMPLEMENTATION OF AN INTERLOCAL AGREEMENT WITH CAPITAL**  
11 **METROPOLITAN TRANSPORTATION AUTHORITY.**

13 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

15 **PART 1.** Council authorizes the acceptance of \$1,000,000 in funds from the Capital  
16 Metropolitan Transportation Authority (Capital Metro) to be used for implementation of  
17 an interlocal agreement with Capital Metro to develop and construct transportation  
18 improvements to benefit both Capital Metro and the City of Austin.

19 **PART 2.** Council amends the Fiscal Year 2017-2018 Austin Transportation  
20 Department's Operating Budget Special Revenue Fund (Ordinance No. 20170913-001) to  
21 appropriate \$1,000,000 in funds from Capital Metro to be used for implementation of an  
22 interlocal agreement with Capital Metro to develop and construct transportation  
23 improvements to benefit both Capital Metro and the City of Austin.

24 **PART 3.** Council amends the Fiscal Year 2017-2018 Austin Transportation Department  
25 Capital Budget (Ordinance No, 20170913-001) to transfer in and appropriate \$1,000,000  
26 in funds from Capital Metro to be used for implementation of an interlocal agreement  
27 with Capital Metro to develop and construct transportation improvements to benefit both  
28 Capital Metro and the City of Austin.

29 **PART 4.** Council authorizes the City Manager to negotiate and execute an interlocal  
30 agreement with Capital Metro to develop and construct transportation improvements to  
31 benefit both Capital Metro and the City of Austin.
