

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, MARCH 8, 2018

Invocation: Reverend Dusty McCormick, Associate Minister, Mt. Zion Baptist Church

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, March 8, 2018 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 10:18 a.m.

CONSENT AGENDA

The following items were acted on by one motion.

1. Approve the minutes of the Austin City Council discussion of February 20, 2018, budget work session of February 21, work session of February 27, 2018, and regular meeting of March 1, 2018.

The motion approving the minutes of the City Council discussion of February 20, 2018, budget work session of February 21, 2018, work session of February 27, 2018 and regular meeting of March 1, 2018 were approved on consent on Council Member Alter's motion, Council Member Troxclair's second on an 11-0 vote.

Authorize award and execution of a construction contract with Johnson Controls, Inc., for the Domain District Cooling Plant Chiller #11 Supply and Installation Project, in the amount of \$2,839,020 plus a \$141,951 contingency, for a total contract amount not to exceed \$2,980,971. [Note: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) by meeting the goals with 1.79% MBE and 11.25% WBE participation.] District(s) Affected: District 7. February 26, 2018 – Recommended by the Electric Utility Commission on a vote of 8-0 with Commissioner Wray absent and two vacancies.

The motion authorizing award and execution of a construction contract with Johnson Controls, Inc. was approved on consent on Council Member Alter's motion, Council Member Troxclair's second on a 10-1 vote. Council Member Troxclair voted nay.

3. Authorize negotiation and execution of an amendment to the contract with the Greater Austin Asian Chamber of Commerce to add additional business development services and to increase the contract amount by \$60,000, from \$142,500 to \$202,500, with one additional 12 month option for a total contract amount not to exceed \$832,500.

The motion authorizing negotiation and execution of an amendment to the contract with the Greater Austin Asian Chamber of Commerce was approved on Council Member Alter's

motion, Council Member Troxclair's second on a 10-1 vote. Council Member Troxclair voted nay.

Item 4 was pulled for discussion.

5. Authorize negotiation and execution of a contract with Wallace Roberts & Todd, LLC, or one of the other qualified offerors to Request For Proposals 8600 SLW0522, to provide a parks and recreation long range plan, in an amount not to exceed \$400,000. (Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program and subcontractor goals were applied to the solicitation. The subcontracting goals were exceeded and the resulting contract will include 19.75% MBE/WBE combined participation).

The motion authorizing negotiation and execution of a contract with Wallace Roberts & Todd, LLC. was approved on consent on Council Member Alter's motion, Council Member Troxclair's second on an 11-0vote.

6. Authorize negotiation and execution of a multi-term contract with Communication By Hand, LLC, or one of the other qualified offerors to Request For Proposals 5800 MHJ0116, to provide sign language interpreters, for up to five years for a total contract amount not to exceed \$905,000. (Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9C, Minority Owned and Women Owned Business Enterprise Procurement Program. For the services required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

The motion authorizing negotiation and execution of a multi-term contract with Communication By Hand, LLC. was approved on consent on Council Member Alter's motion, Council Member Troxclair's second on an 11-0 vote.

7. Authorize negotiation and execution of an additional contract through the State of Texas SmartBuy cooperative purchasing program with Evenflo Company Inc., for infant and toddler car seats, in an amount not to exceed \$25,000, for a total aggregate contract amount for this fiscal year not to exceed \$83,000. (Note: This procurement was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this procurement, there were no subcontracting opportunities; therefore, no subcontracting goals were established). The motion authorizing negotiation and execution of an additional contract through the State of Texas Smart Buy cooperative purchasing program with Evenflo Company Inc. was approved on consent on Council Member Alter's motion, Council Member Troxclair's

second on an 11-0 vote.
8. Direction was given to staff to provide additional improved data tracking whether arrests are resulting in dismissals or deferred adjudication; and to measure the performance of the system.

The amendment to strike the three bullet points to the first Be It Resolved clause and revise the first Be It Resolved clause was made by Mayor Pro Tem Tovo and accepted without objection.

The amendment was to read: "The Council directs the City Manager to propose a preference policy that relates to the distribution of affordable housing units for low-and moderate-income households based on generational ties to the City. The proposed policy must be designed to further the City's obligation to affirmatively further fair housing and should include a method to prioritize the waitlist for programs and resources, such as homeownership and rental assistance programs, for low- and moderate-income households who are displaced."

The Council amends Fiscal Year 2017-2018 Austin Water Operating Budget of Ordinance No. 20170913-001 to reduce total water and wastewater revenue by \$11, 643, 355.00, decrease debt service requirements by \$2,978,413.00, and increase transfers out by \$9,566,159.00, resulting in an ending balance decrease of \$18,231,101.00.

The amendment was to add a new Industrial Waste Surcharge for ammonia-nitrogen to Exhibit A to read as follows:

The surcharge fee for ammonia nitrogen will be charged to an Industrial User that uses or produces ammonia-nitrogen in a manufacturing process. The surcharge fee for ammonianitrogen will be determined by calculating the difference between the average concentrations discharged from such an Industrial User and the 35 mg/l threshold as described in the formula below:

Surcharge fee for ammonia-nitrogen	=	Volume of wastewater discharged (in millions of gallons) x 8.34 pounds per gallon x
		[\$1.559 per pound x (Industrial User's average ammonia-nitrogen (in mg/l) – 35 mg/l)]

Industrial Water Surcharges for BOD, COD, or SS remain unchanged.

A motion to include direction to staff was made as follows: "approve the latest staff recommended rate reduction and associated budget amendments on all 3 readings with direction to staff that prior to the next rate change being implemented, the independent hearings process for Austin Water will be completed" was approved on Council Member Troxclair's motion, Council Member Kitchen's second on a 7-2 vote. Those voting aye were: Mayor Adler, Council Members Alter, Flannigan, Houston, Kitchen, Pool and Troxclair. Those voting nay were: Mayor Pro Tem Tovo and Council Member Renteria. Council Members Casar and Garza were off the dais.

A motion to revise the direction to read "Council directs the manager to engage in independent hearing examiner process prior to proposing a rate increase to council if the rate increase is 3% or greater per year or 7% over five years" failed on Mayor Pro Tem Tovo's motion, Council Member Garza's second on a 5-5 vote. Those voting aye were: Mayor Pro Tem Tovo, Council Members Flannigan, Houston, Garza and Renteria. Those voting nay were: Mayor Adler, Council Members Alter, Kitchen, Pool and Troxclair. Council Member Casar was off the dais.

A motion to revise the direction to read "Council directs the manager to engage in independent hearing examiner process prior to a proposing rate increase to council if the rate is more than 1% in any given year and more than 3% in any five years" was made by Mayor Adler and seconded by Council Member Flannigan. The amendment was later withdrawn.

The public hearing was conducted and a motion to close the public hearing and approve Ordinance No. 20180308-035 was approved as amended above on Council Member Troxclair's motion, Council Member Flannigan's second on a 9-0 vote. Council Members Casar and Garza were off the dais.
