



**AUSTIN CITY COUNCIL  
MINUTES**

**WORK SESSION MEETING  
TUESDAY, MARCH 6, 2018**

The City Council of Austin, Texas convened in a Work Session Meeting on Tuesday, March 6, 2018, City Hall at 301 W. Second Street, Austin, Texas.

Mayor Adler called the Council Meeting to order at 9:10 a.m.

**BRIEFINGS**

- B1. Briefing on the Redevelopment process of City-owned Land.  
Presentation was made by Greg Canally, Deputy Chief Financial Officer; Lauraine Rizer, Real Estate Officer; and Christine Maguire, Manager, Economic Development Department.

Direction was given to staff to provide a list of uses being considered; establish a method and criteria that would allow a proposal for use of the land to align with the Council Strategic Outcomes; the criteria used to identify the sites selected or not selected; different scenarios of options for the properties including selling the property or using the property to meet Council goals such as affordable housing; details on the percentage of affordable housing included in the BAM South – Brooklyn Cultural District project; clarification on what is coming back to Council in June; status on the creation of the strategic facilities governance team; and options for considering the Bolm Road property as a possible creative space use.

- B2. Briefing on the Gentrification and Displacement Study and Mapping Initiative  
Presentation was made by Joe Pantaloni, Interim Assistant City Manager; Mandy DeMayo, Community Development Administrator, Neighborhood Housing and Community Development; Heather Way, Clinical Professor and Director of Entrepreneurship and Community Development Clinic, University of Texas; and Jake Wegmann, Assistant Professor, Community and Regional Planning, School of Architecture, University of Texas.

Direction was given to staff to provide Council the electronic version of the maps for easier viewing; a list of any tracts that were excluded from the study; options for addressing issues that prevent property being passed down in a family resulting in the loss of wealth for low income residents; recommendations on what Council should and should not do; information on the effects of gentrification and displacement on the middle class families and options for addressing the loss of middle class families; options for surveying families that have left Austin and what could have been done to prevent it; a profile of individuals who are being threatened by continued gentrification; identify City policies that either help or hurt areas

**threatened by gentrification; any analysis or studies on the impact of low wages on gentrification; and the list of all policies being reviewed.**

- B3. Briefing and discussion related to the implementation of CodeNEXT and to CodeNEXT proposed regulations.

Conduct a public hearing and consider an ordinance amending the rates charged to Austin Water's retail customers for water and wastewater services (Exhibit A to Ordinance No. 20170913-002) and amending Austin Water's 2017-2018 Operating Budget (Ordinance No. 20170913-001) to account for the corresponding reduction in revenue.
