**§ 2-5-102 MEMBERSHIP OF COUNCIL COMMITTEES.**

~~(1) The council may only ratify the appointments of members, including the designations of officers, made to all of the council committees as a whole. The council may not individually ratify or object to:~~

1 (a) ~~the appointment of an individual council member to a~~  
2 ~~committee;~~

3 (b) ~~the designation of an individual council member as a~~  
4 ~~committee officer; or~~

5 (c) ~~the membership of a particular committee.~~

6 (2) ~~If a motion to ratify the mayor's appointment of the membership~~  
7 ~~of all the council committees fails, the mayor must appoint a new~~  
8 ~~set of members and officers for the committees and submit the~~  
9 ~~new appointments to the council for ratification. The new set of~~  
10 ~~members need not be completely different from the set that~~  
11 ~~council did not ratify.]~~

12 [(E) ~~If a vacancy occurs on a committee, the mayor shall appoint a council~~  
13 ~~member to fill the vacancy for the remainder of the unexpired term. An~~  
14 ~~appointment under this subsection does not require council~~  
15 ~~ratification.]~~

16 [(F)](C) ~~[Each appointment under this section must be in writing and filed with~~  
17 ~~the city clerk. If an appointment requires council ratification, council~~  
18 ~~must ratify the appointment in a written resolution.]~~Immediately  
19 following the work session when council members select council  
20 committees on which to serve or when council members make changes  
21 to council committee membership, the mayor shall file a list of the  
22 membership of each council committee with the city clerk.

24 **PART 2.** Subsection (B) of Section 2-5-105 (*Committee Meetings*) is amended to

27 (B) ~~[Except as otherwise provided, three]~~A majority of the total number of  
28 members of a council committee [are] is a quorum. The favorable votes  
29 of a majority of the council committee quorum present at the  
30 meeting-are required for a council committee to take action.
