# Late Backup

I move to amend the proposed ordinance as follows:

# **PART 1** – § 14-9-1(A)(1)

Amend to "<u>display, cause to be displayed</u>, suspend, or offer merchandise <u>or dockless</u> <u>transportation services for sale, lease, or rental in the public right-of-way or on a [over the]</u> sidewalk in front of a business, residence, or other premises within the person's control; or"

## **PART 2** - § 14-9-3(A)

Amend to "A person may not place, store, or park, or <u>allow [permit]</u> another person to place, store, or park, a vehicle, machinery, <u>dockless transportation item</u>, or <u>bulky other</u> [bulky] item on a street, alley, or sidewalk [for more than one hour]:"

## **PART 3** – § 14-9-11(A)

Amend to "Except as provided in Subsection (B), a person may not <u>display</u>, sell, offer for sale, exchange, or take orders for the sale or exchange of merchandise, <u>or dockless</u> transportation goods services, rentals or lease within City right-of-way adjacent to schools, <u>hospitals</u>, convention centers, City owned or controlled buildings, streets, highways, <u>bridges</u>, alleys, sidewalks, and any places deemed detrimental to safety and mobility as <u>determined by the director of the Austin Transportation Department (director)</u>, [in an area <u>described in this section]</u> unless the person has obtained a license from the City[±]."

#### **PART 4** – § 14-9-12(B)

Amend to "On a street, highway, bridge, alley, sidewalk, or right-of-way, a person may not:

(1) place, park, or maintain, or cause to be placed, parked, or maintained a structure or display used to sell, offer for sale, <u>lease</u>, <u>rental</u>, <u>barter</u>, trade, store, or take an order for the sale, <u>lease</u>, <u>rental</u>, or exchange of merchandise, <u>or dockless</u> transportation goods<sub> $\overline{1}$ </sub> or services; or

(2) sell, offer for sale, <u>rent, lease</u>, exchange, or take orders for the sale or exchange of merchandise, <u>or dockless transportation goods or services</u>."

#### **PART 9** – § 14-9-23

Amend title to "CITY WIDE <u>DOCKLESS TRANSPORTATION</u> LICENSE AUTHORIZED."

Amend (A) to "The director may issue a city wide <u>dockless transportation</u> license to a person for use of the public right of-way to sell, offer for sale, rent, lease, exchange, or take orders for <u>dockless transportation</u> merchandise, goods, or services."

#### **PART 10** – § 14-9-24

Amend title to "CITY WIDE <u>DOCKLESS TRANSPORTATION</u> UNIT PLACEMENT PLAN"

Amend (A) to "An applicant for a city wide <u>dockless transportation</u> license shall provide the director a plan that shows the number of units to be deployed in specific areas of the City."
