

## **ORDINANCE NO**

**AN ORDINANCE ACCEPTING GRANT FUNDS FROM THE TEXAS DEPARTMENT OF PUBLIC SAFETY AND AMENDING THE FISCAL YEAR 2017-2018 BUDGET SPECIAL REVENUE FUND (ORDINANCE NO. 20170913-001) TO APPROPRIATE THESE FUNDS FOR REPAIRS TO CITY FACILITIES AND REPLACEMENT OF CITY PROPERTY DAMAGED OR DESTROYED BY THE FLOODING OF MAY AND OCTOBER 2015; AND AMENDING THE FISCAL YEAR 2017-2018 CAPITAL BUDGET (ORDINANCE 20170913-001) TO TRANSFER IN AND APPROPRIATE GRANT FUNDS FOR REPAIRS TO CITY FACILITIES AND REPLACEMENT OF CITY PROPERTY DAMAGED OR DESTROYED BY THE FLOODING OF MAY AND OCTOBER 2015.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** Council accepts grant funds from the Texas Department of Public Safety in the amount of \$9,980,495 for repairs to City facilities and replacement of City property damaged or destroyed by the flooding of May and October 2015.

**PART 2.** Council amends the Fiscal Year 2017-2018 Budget Special Revenue Fund (Ordinance No. 20170913-001) to appropriate the \$9,980,495 as follows: Austin Code \$7,547, Austin Energy \$180,633, Austin Fire Department \$51,769, Austin Police Department \$371,569, Austin Resource Recovery \$388,624, Austin Water \$129,216, Emergency Medical Services \$14,591, Fleet \$1,848, Homeland Security and Emergency Management \$37,811, Parks and Recreation Department \$14,591, Public Works Department \$266,307, and Watershed Protection \$8,515,564 for repairs to City facilities and replacement of City property damaged or destroyed by the flooding of May and October 2015.

**PART 3.** Council amends the Fiscal Year 2017-2018 Capital Budget (Ordinance No. 20170913-001) to transfer in and appropriate \$8,644,901 for the following departments: Austin Water \$129,216, Watershed Protection \$8,515,684 for repairs to City facilities and replacement of City property damaged or destroyed by the flooding of May and October 2015.
