AN ORDINANCE AMENDING ORDINANCE NO. 20160629-001 TO INCREASE THE VALUE OF A PERCENTAGE-BASED HOMESTEAD EXEMPTION FROM AD VALOREM TAXES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN

PART 1. Findings:

- (A) According to data collected by Texas A&M Real Estate Center, the medianvalue home in Austin has experienced a 68.4% increase in City property taxes from 2005 to 2014 while the median income has remained relatively flat.
- (B) Travis County currently offers homeowners the maximum 20% homestead exemption on county property taxes, and other major cities in Texas, including Houston, Dallas, and Fort Worth offer homeowners a 20% homestead exemption.
- (C) In a 2015 Zandan Poll, Voices of the Austin Community, 79% of Austin residents indicated their support for a full 20% homestead exemption.
- (D) On June 4th 2015, the City Council passed Ordinance No. 20150604-010, which increased the homestead exemption to 6% and stated the Council's goal to phase in the full 20% exemption.
- (E) The City Council reaffirmed that commitment to phase in the full 20% homestead exemption on June 29th, 2016 when the homestead exemption was increased to 8%.
- (F) Increasing the homestead exemption is one of the ways that the City can slow the increase of an Austin homeowner's rising tax bill.
