## **Purchasing Office**

Authorize award and execution of a multi-term contract with DXI Industries Inc., to provide liquid sulfur dioxide, for up to five years for a total contract amount not to exceed \$1,455,000. (Note: This solicitation was reviewed for subcontracting opportunities in accordance with City Code Chapter 2-9D Minority Owned and Women Owned Business Enterprise Procurement Program. For the goods required for this solicitation, there were no subcontracting opportunities; therefore, no subcontracting goals were established).

### Additional Backup Information:

The contract will provide liquid sulfur dioxide to be used at Austin Water treatment plants. The solution of sulfur dioxide is used to dechlorinate the wastewater effluent prior to being discharged into receiving streams. This protects aquatic life from toxic effects of residual chlorine in wastewater. This treatment process is a requirement by the Texas Commission on Environmental Quality (TCEQ) for the City's discharge permit for the City's treatment facilities. The City treats approximately 105 million gallons of water a day.

The current contract will expire June 19, 2018. The requested authorization amount for the proposed contract was determined by departmental estimates, historical spend, and forecasted future chemical usage. The use of liquid sulfur dioxide has increased significantly, primarily due to the establishment of new Escherichia coli bacteria limits in the treated wastewater effluent set forth by the TCEQ. The recommended contractor is the current provider for these goods.

If the City is unable to secure a contract, purchases would need to be made by spot purchases on an asneeded basis, resulting in higher costs to avoid potential harm to the environment and possible TCEQ discharge permit violations.
